This project will supply the regional tech rescue team with the necessary equipment that has been identified by inventory and risk analysis conducted by the individual team leaders.

### **Project Need:**

This equipment will continue to fill in gaps that have been identified by inventory and risk analysis conducted by the individual team leaders. Current requests are funneled into a single Project Justification per disciple per fiscal year.

This accomplishes several goals set by the Central Mass Tech Rescue Consortium, a committee of Chiefs and Team Leaders representing all Central Mass Tech Teams. First, by presenting equipment lists simultaneously, team leaders can address shortfalls identified by the other teams. Second, this allows for easier identification that all new equipment purchased is interoperable between teams. In the event of a large-scale incident, team members will be familiar with the use of all local teams' equipment. Third, his procedure has the potential of improving bulk pricing during procurement by MAPC. Finally, this should lower the overall number of PJ's written for one discipline during a single fiscal year, making projects easier to manage. ### **Project Need**:

The Worcester Police Department currently operates four Explosive Detection K-9 teams and is one of only two Central Massachusetts communities with operational EOD dogs. These teams require updated, fully equipped cruisers to maintain readiness, ensure the safety of both handlers and canines, and support regional deployment capabilities. Properly equipped cruisers serve as mobile offices and working environments for handlers, enabling rapid and reliable responses to EOD-related incidents and terrorism threats throughout Worcester and the region. Two of our EOD cruisers that are being operated for EOD purposes are a 2012 cruiser with 131,000 and a 2013 cruiser with 183,000 miles. I would also like to note that the 2013 cruiser was a cruiser that was obtained through this grant and is still operable, showing the long term sustainability and the care in which the handlers and the department take care of the cruisers when granted to us.

### Measurable Outcomes:

- Maintain continuous EOD K-9 response capability for Worcester and surrounding communities.
- Reduce response time to EOD incidents and regional deployment requests.
- Enhance public safety and preparedness for large-scale events, protests, and festivals.

To Whom It May Concern,

My name is Daniel Pennellatore, and I am a Police Officer with the Worcester Police Department (WPD). I currently serve as the Head Trainer for the WPD K-9 Unit, the Assistant Trainer for the Boston Police K-9 Academy, and am nationally certified as a K-9 Trainer through the North American Police Work Dog Association (NAPWDA).

I am writing to respectfully request funding for two (2) police cruisers dedicated to our Explosive Ordnance Detection (EOD) K-9 teams. This project directly supports multiple eligible project categories under the FFY 2025 CRHSAC guidance:

- 1. Enhancing the protection of soft targets and crowded places
- 2. Combatting domestic violent extremism
- 3. Enhancing community preparedness and resilience
- 4. Enhancing election security

### **Community Overview and Need**

The City of Worcester is the second-largest city in New England, with a census population of approximately 210,000 residents. Worcester is also home to eight major colleges and universities, adding more than 40,000 students to the city's population throughout the year. As the primary urban hub of Central Massachusetts, Worcester attracts millions of visitors annually through its air, rail, and ground transportation systems. We are also the primary law enforcement agency for all ground transportation in the city and rail transportation in the city keeping both the WRTA and Union station safe.

The Worcester Police Department currently operates four Explosive Detection K-9 teams. We are one of only two communities in Central Massachusetts with operational EOD dogs—and among the few between Worcester and the New York state line. These teams are frequently deployed not only within the city but across the Central Massachusetts region and throughout the Commonwealth, in support of the Massachusetts State Police Bomb Squad and other partner agencies.

Our handlers spend 40+ hours per week in their assigned cruisers, which serve as both their mobile office and canine workspace. The specialized vehicles are critical to maintaining readiness, ensuring the safety and comfort of both the officer and the K-9, and allowing immediate deployment to regional emergencies.

### **Operational Impact and Regional Benefit**

Our EOD teams play a key role in preventing and mitigating acts of terrorism by providing protective sweeps and response capabilities

for major events across Worcester and neighboring communities.

### **Examples include:**

- Large-scale city events at Polar Park, the DCU Center, and The Palladium
- Annual ethnic and cultural festivals such as the Caribbean Festival, Italian Festival, and Polish Festival
- Citywide protests, demonstrations, and political rallies
- Regional deployments including the Boston Marathon, Boston 4th of July Celebration, and events at Gillette Stadium
- Mutual aid responses in nearby communities such as Charlton, Leicester, and Douglas

The requested cruisers will ensure that these EOD K-9 teams remain fully mobile, mission-ready, and regionally deployable for terrorism prevention and rapid response operations.

1. Enhancing the Protection of Soft Targets and Crowded Places Our EOD teams conduct pre-event sweeps and remain on-scene during high-attendance events. These actions provide early threat detection and rapid mitigation capability for any

The visible presence of EOD K-9 teams acts as a deterrent to would-be attackers and provides reassurance to the public. Each deployment directly supports federal and state priorities in countering domestic violent extremism.

As the saying goes, "If you fail to prepare, you prepare to fail." Our teams proactively identify and eliminate threats before events begin, strengthening Worcester's overall preparedness and resilience against potential attacks.

During each election cycle, EOD K-9 teams remain on standby to respond to any threats at polling locations, ensuring the public's uninterrupted ability to vote safely and securely.
